**BACKGROUND:** The *Accreditation of Prior Experiential Learning in the Western Balkans (APEL-WB)* project builds on the principles of the Lisbon Recognition Convention, emphasizing the value of learning gained through self-education, work, and life experiences. The project aims to institutionalize Recognition and Accreditation of Prior Informal and Non-Formal Learning (RAPL) in the Western Balkans as a systemic cornerstone of inclusive higher education. Aligned with European Higher Education Area and regional priorities for sustainable growth and knowledge-based economies, APEL-WB promotes lifelong learning and equitable access to education. The project will establish a comprehensive framework for RAPL, develop normative guidelines, and provide training for experts from higher education institutions, quality assurance agencies, and ministries of education.

**POSITION OVERVIEW:** LOGOS University College, as the Coordinator of the APEL-WB Project, invites applications for the position of External Quality Evaluation Expert or Organization. The appointed expert or organization will evaluate the quality of project implementation; provide independent analysis and recommendations on reports submitted by the Quality Monitoring Committee; and support the General Management Committee by offering expert consultation on quality standards and improvement strategies.

**KEY QUALIFICATIONS:** Candidates must demonstrate relevant academic and professional experience through their CV and supporting documentation. Each qualification listed below will be evaluated according to the predefined scoring grid (0–5 scale). **1**. Ph.D. degree, preferably with academic rank; **2**. Teaching experience in higher education; **3**. Record of leadership or membership in quality assurance bodies; **4**. Participation in projects related to qualification frameworks and recognition of learning in higher education; **5**. Excellent command of English language; **6**. Understanding of the European Higher Education Area; **7**. Familiarity with higher education systems in the Western Balkans.
